Bicycles-Moped-Motorcycle (Wheeled Vehicle) Policy:

All "wheeled vehicles" (except those that assist disabled persons navigate through campus and/or St. Norbert College service/safety vehicles) are not allowed to be ridden on the **internal campus sidewalks**.

Student mopeds/motorcycles need to register with the parking office. Contact the Parking office (parking@snc.edu) with the plate of the moped/motorcycle and the operator's name and phone number.

Mopeds/motorcycles must be parked in identified motorcycle parking areas. (Just north of the 3rd Street entrance to lot #6 and in the lower PAC lot #3 on the east end of the PAC building). **Mopeds and/or motorcycles cannot be parked in campus bike racks.** Violators will be ticketed and or towed.

MOPEDS/SCOOTERS/MOTORCYCLES must be removed from campus parking lots by Winter break. These vehicles cannot be stored on campus during the winter months.

Wheeled vehicles include scooters (motorized & non-motorized), bicycles, in-line skates and roller blades, skateboards, etc.

Bicycles Policy:

- *No permit required. The College is not responsible for lost, stolen, or damaged bicycles.
- *The College is not responsible for locating lost or stolen bicycles.
- *Bicycles **may not** be ridden/stored in buildings, including residence halls.
- *Bicycle owners are encouraged to have bikes insured in case of damage, loss, or theft.

Bicyclists are responsible for the safe operation of their bicycles at all times. "Reckless operation" of a bicycle is defined as operating a bicycle in such a manner as to indicate either a willful or wanton disregard for the safety of persons or property.

Bicycles, when not in use, **must be** securely locked to approved bicycle racks. Bicycle racks will be placed in appropriate places on campus. Bicycles **may not** be secured to trees, poles, stairways, railings, handrails, or guard rails including, but not limited to, those railings or other objects that may be required by persons with mobility impairments.

Removal notice: A notice will be provided via SNC News to indicate the date when bicycles need to be removed from campus bicycle racks.

Bicycle owners are responsible for removing their bicycles from all campus bicycle racks (except the one under the 3M canopy) **PRIOR** to Thanksgiving break. The bicycles are removed from racks so the Grounds Department can clear snow from the internal sidewalks. Confiscated bikes are held by the College until the bicycle is claimed or disposed of. **The college does not assume responsibility for locks cut for bicycle storage.**

Storage:

Outdoor storage is available all year round under the canopy by 3M.

Disposal of bicycles

Bicycles left with Campus Safety for more than 14 days after the end of the semester will be deemed a gift to the College, to be disposed of through appropriate College channels.
